As we look towards the new academic year, we would like to take a moment to express our gratitude for your continued support of our school community. Many of you have contacted our local MP to express concerns about the low level of funding public schools receive, volunteered at school events, or made contributions. These actions have had a positive impact.

Our 2024 Attitudes to School student survey data shows that students' positive perceptions of Fairhills High School are higher than those at other schools. It is particularly pleasing to see that "Stimulated Learning" is now 10% above similar schools, 16% above our network, and 7% above state averages. This result reflects our efforts to develop innovative programs, such as VEX Robotics. Your contributions allow us to provide the resources needed to offer these engaging opportunities to our students.

Government schools provide free instruction to fulfil the standard Victorian curriculum. However, to continue enhancing the educational experience we offer, we are asking you to consider making a contribution to our school. Your support directly funds various programs, resources, and activities that benefit our students, including STEM, art and sports equipment, state-of-the-art IT facilities, breakfast clubs, teambuilding activities, and specialist programs.

While contributions are voluntary, they play a crucial role in helping us maintain and improve the quality of education we provide. Every contribution makes a difference and is deeply appreciated.

#### **ONE PAGE OVERVIEW**



#### **FREE INSTRUCTION**

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.

#### **PARENT PAYMENT REQUESTS**

Schools can request contributions from parents under three categories:



#### **Curriculum Contributions**

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

## Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

### Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

 Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



#### FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



#### **SCHOOL PROCESSES**

• Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
